# Gardening Agreement for 2020

Earth Community Garden (ECG) is a Charitable, Nonprofit, 501(c)(3) Tax Deductible organization whose goals are to;

- Provide/maintain regenerative-organic community gardens.
- Actively preserve green spaces and open spaces.
- Create a stronger community by providing healthy pantry food at no cost to those in need of nutritional assistance.
- Educate the public by raising awareness about; the environment, environmental regeneration, xeriscaping, organic gardening & land cultivation by encouraging community involvement.
- Raise funds for regenerative-organic community gardens and community garden events.

\_\_\_\_\_ **LAND USE AGREEMENT:** This agreement is for the current calendar year (January 1st - December 31st). I understand that ECG has made a contractual agreement with the land owners for sole decision making purposes of the land in accordance with ECG's goals. Land use is conditional and can be revoked by ECG or property owners. I AM A GUEST ON THE PROPERTY.

\_\_\_\_\_ **FINANCIAL AGREEMENT:** I agree to put down a deposit of \$10 per plot for this calendar year, plus;

- \$25 for a Private Raised Plot in the north parking lot
- \$0 for a Public Gleaning Plot on the park strip between the sidewalk and the street along either the East or South side of the property.
- \$125 Sponsorship of one of the Private Raised Plots [INCLUDES SPONSORSHIP SIGN].
- \$65 Sponsorship for one of the Public Gleaning Plots [INCLUDES SPONSORSHIP SIGN].

All funds to ECG or donated produce will be used for charitable purposes compliant with the IRS 501(c)(3) tax code.

\_\_\_\_\_ **GARDENING METHODS:** I agree to use sustainable-organic methods. I agree to let the Gardening Steward water my plot and follow the Watering Guidelines set up by the Gardening Steward. I agree to use all sustainable-organic methods of pesticides, fertilizers, and weed control. I will refrain from any other methods that may be harmful or hazardous to the environment. THINK GREEN.

\_\_\_\_\_ **PLOT AGREEMENT:** I will maintain and prepare my own plot. PLOT # \_\_\_\_\_  
This includes clearing a parameter of 14" from growth all the way around my 4' x 10' plot, harvesting in a timely manner to prevent wasted produce, and preparing it for the next season with leaves, manure, compost or a cover crop. I will only take crop from my own plot, unless given permission to take from another plot by that gardener.  
Prepare Plot by **May 16, 2020** & Winterize Plot by **November 28, 2020**. BE A GOOD **COMMUNITY** GARDENER.

\_\_\_\_\_ **COMMUNITY TASKS:** I will commit to 10 hours per garden season to common aspects/community tasks of the garden. Please underline tasks (fund raising, column steward, composting, education/workshops, beautification, community plots, newsletter, tools, events).
